Annual Equipment List Review

Consistent with the "Recommendations Pursuant to Executive Order 13688," the Permanent Working Group (PWG) conducted an annual evaluation and review of the items on the Prohibited and Controlled Equipment Lists to determine whether equipment categories should be added, deleted, or refined. The first annual review took place from July to September 2016 and included significant input from civil rights, law enforcement, and other relevant stakeholder groups. The changes below will take effect in Fiscal Year 2017 (beginning October 1, 2016).

Tracked Armored Vehicles: Vehicles that provide ballistic protection to their occupants and utilize a tracked system instead of wheels for forward motion.	[No Change]

Unmanned Aerial Vehicles: A remotely piloted, powered aircraft without a crew aboard.	[No Change]	
Armored Vehicles, Wheeled: Any wheeled vehicle either purpose-built or modified to provide ballistic protection to its occupants, such as a Mine-Resistant Ambush Protected (MRAP) vehicle or an Armored Personnel Carrier. These vehicles are sometimes used by law enforcement personnel involved in dangerous operating conditions, including active shooter or similar high-threat situations. These vehicles often have weaponfiring ports.	[No Change]

Tactical Vehicles, Wheeled: A vehicle purpose-built to operate on- and off-road in support of military operations, such as a HMMWV ("Humvee"), 2.5-ton truck, 5-ton truck, or a vehicle with a breaching or entry apparatus attached. These vehicles are sometimes used by law enforcement in rough terrain or inclement weather for search and rescue operations, as well as other law enforcement functions.	Tactical Vehicles, Wheeled: A vehicle purpose-built to operate on- and off-road in support of military operations, such as a HMMWV ("Humvee"), 2.5-ton truck, or 5-ton truck, or a vehicle with a breaching or entry apparatus attached. Command and Control Vehicles: Any wheeled vehicle either purpose-built or modified to facilitate the operational control and direction of public safety units responding to an incident. Command and Control vehicles provide a variety of capabilities to the incident Commander, including, but not limited to, the provision for enhanced communications and other situational awareness capabilities. Command and Control Vehicles are similar to a recreational vehicle and can accommodate multiple people at multiple workstations in the command center. This category is not intended for other types of vehicles that could serve as a command and control center, including SUVs. Specialized Firearms and Ammunition Under .50-Caliber (excludes firearms and ammunition for service-issued weapons): Weapons and corresponding ammunition for specialized operations or assignment. This excludes service-issued handguns, rifles, or shotguns that are issued or approved by the agency to be used during the course of regularly assigned duties.	Specialized Firearms and Ammunition Under .50 Caliber (excludes firearms and ammunition designed for regularly-assigned duties), and Less Lethal Launchers: Weapons and corresponding ammunition for specialized operations or assignment. This includes launchers specifically designed and built to launch less lethal projectiles. This excludes weapons, such as service-issued handguns, rifles, or shotguns, that are issued or approved by the agency to be used by all sworn officers/deputies during the course of regularly assigned duties.	This definition clarifies that less lethal launchers are Controlled Equipment. Previously, it was unclear whether Less Lethal Launchers were prohibited under the "Grenade Launchers" category or entirely excluded from the Prohibited or Controlled Equipment Lists. The phrase "service-issued" has been supplemented to clarify that this refers to equipment issued to all sworn officers / deputies in the agency.
Explosives and Pyrotechnics: Includes "flash bangs" as well as explosive breaching tools often used by special operations units.	[No Change]	
Breaching Apparatus (e.g. battering ram or similar entry device): Tools designed to provide law enforcement rapid entry into a building or through a secured doorway. These tools may be mechanical in nature (a battering ram), ballistic (slugs), or explosive. These tools may be mechanical in nature (a battering ram connected to a vehicle or a propellant), ballistic (slugs), or explosive. Riot/Crowd Control Batons and Shields continue to be Controlled Equipment.
Riot Shields: Shields intended to protect wielders from their head to their knees in melees. Most are designed for the protection of the user from projectiles including rocks, bricks, and liquids. Some afford limited ballistic protection as well. Riot shields may also be used as an offensive weapon to push opponents.	Riot/Crowd Control Shields: Shields intended to protect wielders from their head to their knees in crowd control situations. Most are designed for the protection of the user from projectiles including rocks, bricks, and liquids. Some afford limited ballistic protection as well.	The title of this category has been modified. The term "melees" has been replaced with "crowd control."
