Dear Chairman McCaul, Chairman Rogers, Ranking Member Thompson, and Ranking Member Ruppersberger:

We are writing to express opposition and serious concern with a House Permanent Select Committee on Intelligence proposal that would dramatically change the relationship between the Department of Homeland Security and the National Network of Fusion Centers, and negatively impact the ability of the Office of Intelligence and Analysis (I&A) to support the national homeland security mission.

Specifically we are concerned about proposals to redeploy DHS Intelligence Officers (IOs) from individual fusion centers to the 12 DNI regions, and to restrict I&A's ability to develop certain analytical products that are consumed by fusion centers and state and local law enforcement.

From the state and local operational perspective, the effect of these proposals would be decreased analysis and information sharing on threats impacting our jurisdictions, and a decrease in our ability to provide information to our federal partners in support of a range of investigations including terrorism. Redeploying IOs to the 12 federal DNI regions would sever the critical tie between state and local information and its potential nexus to national security threats, as originally envisioned in the 9/11 Commission recommendations.

As we understand them, these proposals would represent a decreased commitment by Congress and the federal government to analysis and sharing of information on all threats. If enacted, this would put in reverse the progress we have made over the past decade.

The state and local law enforcement community has dedicated an enormous amount of effort in recent years in collaboration with DHS, DOJ, FBI, ODNI, PM-ISE and others to enhance our collective ability to protect American citizens through better analysis and sharing of criminal and terrorism intelligence. The partnerships that have been developed thus far have resulted in unprecedented coordination and countless successes in our communities.

We are committed to continuous improvement and would like to work closely with your committees on ideas to enhance our overall capabilities and ensure good return on investment at all levels. Unfortunately, the HPSCI proposals under consideration do not reflect the interests of the National Network of Fusion Centers, or of state and local law enforcement as a whole. We urge opposition to these proposals.
