As a victim of a drunk driving crash, you are entitled to the same referrals for services, support, and resources due victims of other violent crimes.

#### **GET MEDICAL ATTENTION**

Even if you do not have any signs or feelings of injury at the crash scene, ask for an ambulance to transport you to the hospital for examination by a doctor. Drunk driving crashes are a leading cause of traumatic brain injury (also known as closed head injury), in which the brain is injured without the skull being fractured.



#### **APPLY FOR COMPENSATION**

State crime victim compensation programs ensure victims receive the financial assistance needed to pay for medical care, counseling, lost income, funeral bills and many other expenses DUI victims or their survivors incur.

Compensation program staff rely on the police report to determine the facts of a case. Those facts may influence a victim's eligibility. Thus, it is important that you obtain a report from the officer as soon as possible.

#### **VICTIMS' RIGHTS**

You have legal rights and protections as a DUI crash victim or survivor, including: to be informed of criminal justice proceedings; to attend and be heard at proceedings; to submit a *victim impact statement*, telling the prosecutor and judge how this crime affected you and your family, and; to be notified when the DUI driver is released from incarceration.

#### WHAT HAPPENS NEXT?

Tell the officer of any concerns you have or accommodations needed. Let the officer know if there is someone you want contacted immediately. Do not hesitate to ask questions and to ask the officer to repeat answers you don't understand. Ask the officer to write down information you may need later. Ask, what happens next?
