It's Not An "Accident" It's A Crime!

Drunk driving crashes kill thousands of people each year. Thousands more are injured.

DUI is a crime and its perpetrators are criminals.

Victims of drunk driving crashes should be treated no differently by you than any other crime victim. They need the same referrals for services, support, and resources as other victims of a violent crime.

Law enforcement is usually the first to arrive on the scene. You should look at a DUI crash not as a motor vehicle crash but as a crime involving a motor vehicle crash.

The officer who professionally, informatively and compassionately responds to victims of drunk driving crashes will forever be remembered by victims or their survivors as a first responder who made a difference!

FIRST RESPONSE

Drunk driving victimization is usually severe and its consequences longlasting. This makes the role of law enforcement critical.

The way people cope as victims of crime depends largely on their experiences and on how others treat them after the crime. As a first responder, you are in a unique position to assist victims immediately after the crime.

Law enforcement's initial response to a DUI crash is a key factor in whether or not a victim ultimately receives crime victim services and assistance.

Finally, always encourage victims to get immediate medical attention even if no signs of injury are present. Drunk driving crashes are a leading cause of traumatic brain injury (also known as closed head injury), in which the brain is injured without the skull being fractured. Victims with such an injury may exhibit no symptoms and interact normally with you.

VICTIM COMPENSATION

In addition to referring DUI crash victims to a crime victim services provider, another responsibility of law enforcement is providing victims or their survivors with written contact information for State crime victim compensation programs.

Program funds are available to ensure crime victims obtain the financial assistance needed to pay for medical care, counseling, lost income, funeral bills and many other expenses DUI victims or their survivors incur.

Compensation program staff rely on investigative reports to determine the facts of a case. Those facts may influence a victim's eligibility. Thus, it is important that your report be completed and filed promptly.

Victims of Crime Act (VOCA) funds are also available via a State's VOCA administering agency for local law enforcement agencies to assist DUI crash victims through their own agency-based crime victim assistance units.
